

Terms and Conditions - OE-A Web-Seminars

1-Purpose

OE-A expands its services by offering an online 'Printed Electronics Insights' Web-Seminar series, in order to keep our member companies and interested parties up to date on the latest flexible and printed electronics developments from any place they are based.

2-Registration procedure

Registration is possible vie VDMA website. Registrants will receive an automated e-mail confirmation of web-seminar registration upon signing in. Please note, that this e-mail confirmation will <u>not</u> provide the link to join the web-seminar. All registrants will receive a second e-mail confirmation one day prior to the web-seminar including a second registration link to confirm participation with our external service provider GoToWebinar to set-up the web-seminar. Only after completing your information there, your registration process is completed, and you will receive a unique link to join the web-seminar (please do not share this link with others).

When registering for the web-seminar consent is given to process your personal data in connection with the provision of this service. OE-A will use your information to provide access to the web-seminar you registered for, as well as to communicate with you about the web-seminar via e-mail. Furthermore, OE-A will save and use your personal data to invite you to upcoming web-seminars and OE-A meetings. You may withdraw the consent granted either fully or partially at any time with future effect by sending an e-mail to daria.firlus@oe-a.org.

3-Web-seminar participation

Registration for the web-seminar is limited to 1.000 participants. Registrations will be accepted on a "first come, first served" basis. OE-A reserves the right to limit participation to two attendants per company.

3-Payment

Web-seminar participation is free of charge, no registration fee applies. This applies to OE-A members as well as non-members.

4-Cancellation

2-Integration of third-party services

OE-A is using the web conferencing software 'GoToWebinar' to run its web-seminars. 'GoToWebinar' is a service provided by LogMeIn Inc based in the USA. OE-A has no influence on the design, contents and function of those services or the processing of personal data by the provider.

When registering for the web-seminar, data from the registration form (e.g. first name, last name, email address) as well as date and time of registration will be transmitted to LogMeIn, Inc. During the web-seminar itself, data will be collected and transmitted to the service provider, who may also set cookies. Among other things, the IP address is recorded, as well as the provider, the operating system and browser used, language settings, type of device used for the web-seminar and statistical data (e.g. participation status and duration, questions asked, interest in the web-seminar). OE-A is using this data for post-processing of the web-seminar session and to enhance the user experience.

The legal basis for the processing of personal data in connection with the web-seminar is Art. 6 para. 1 b) GDPR. The legal basis for the transmission of personal data to the service provider is Art. 6 para. 1 f) GDPR.
